



Nomination for Avalon Beach SLSC Service Honours Awards

Nomination Guidelines

The following nomination guidelines shall be followed for Avalon Beach SLSC Service Honours Awards.

1. Candidates are to be nominated using the appropriate form by two (2) members of Avalon Beach SLSC.
2. All nominations shall be strictly confidential.

Judging Process

1. The Life Members and Service Honours Awards Committee will review nominations for Club Service honours awards.
2. The panel will provide a recommendation based on the information presented.
3. Formal acknowledgement of recipients of Avalon Beach SLSC Service Honours Awards will be announced by the President.
4. Unsuccessful nominations for Avalon Beach SLSC Service Honours Awards may be re-nominated for consideration after two (2) years.

How to Nominate

- The nomination must establish and argue the case for the Service Honours Award envisioned by the proposer and seconder.
- The proposer is to summarise the nominee's personal achievements that have impacted on Avalon Beach SLSC.
- It is important that the nomination is specific to the nature of the individual's achievements apart from that of a group.
- The nomination should provide substantive evidence to support the claims.

NB – A list of roles that an individual has held is insufficient in demonstrating the significance of that individual's service. The Life Members and Service Honours Committee may return a nomination to the proposer if it feels that a lack of detail may be prejudicial for the nominee.

For service to be considered as distinguished it must be both a sustained and conspicuous contribution.</p> | <p>Avalon Beach SLSC Distinguished Service Member:</p> <ul style="list-style-type: none"> • Will have maintained a sustained level of conspicuous service at a level that brings distinction to that service. • Will have given distinguished service to Avalon Beach SLSC over a period spanning at least 15 years, excepting extraordinary circumstances. • Will have made an individual contribution that can be classified as unique, and which can be attributed to that person as opposed to being a member of a wider group of members. | <p>Key questions to be applied at this level include:</p> <ul style="list-style-type: none"> • What distinguishes this service and contribution beyond that of others? • How has this contribution advanced surf life saving in Avalon Beach SLSC? • What makes this person’s contribution unique amongst the Avalon Beach SLSC membership? • Has the distinguished service spanned at least 15 years? |
